As such, it facilitates fellowship among readers of the book and fosters the development of a religion, philosophy, and cosmology, which are commensurate with the development of civilization.

The Urantia Book Fellowship focuses on the dissemination of the Urantia Book and bringing people together who read and believe in the book. The Fellowship's scholarly website serves 120,000 people per month, where the book in all formats, including audio, is made freely available to everyone. The Fellowship emails a monthly newsletter to 5,000 subscribers and mails quality publications three times a year to 1,800 members and donors. The organization maintains an online directory of 400 active study groups and sponsors and participates in dozens of exhibitions and public gatherings each year, utilizing hundreds of volunteers to expose the book to thousands of potential readers.
